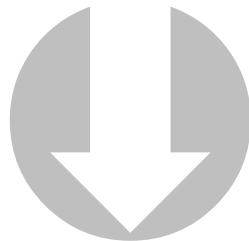


## Call for Artists: 2012 Regional Juried Exhibit

## **Juror**

Justin Henry Miller is currently an Assistant Professor of Art at Southeast Missouri State University where he teaches painting and drawing.

## **Awards**

Cash awards will be given for Best of Show, Second in Show, and three honorary awards. Award recipients will be designated by the Juror, whose decision is final. Awards will be distributed at the exhibition opening reception Friday, December 7, 5-9 pm, at the Arts Council of Southeast Missouri.

## **Sales and Commissions**

Every effort is made to promote sales. The Arts Council of Southeast Missouri will retain a 30% commission.

The Regional Juried Exhibition is sponsored by the Arts Council of Southeast Missouri, and receives financial assistance from the Missouri Arts Council, a state agency.

# Regional Juried Exhibition 2012

## Statement of Purpose

The Arts Council of Southeast Missouri's Regional Juried Art Exhibition was developed to provide a forum to demonstrate the diversity of this region and the artists who live here. We encourage artists to submit works that interpret any aspect of the Southeast Missouri region as well as its bordering states. Work must interpret the people, places, or things that are representational of this 5- state region.

## Eligibility

Open to all area artists 18 years and older living within a 175-mile radius of Cape Girardeau. Entries must be original, two-dimensional works in any medium, not previously exhibited at the Arts Council, or in any Arts Council sponsored Juried Exhibit. Maximum size 48" x 72", including frame. Maximum weight: 75 lbs. Works must be framed and wired for installation. NO SAW TOOTH HANGERS. Three-dimensional pieces must fit through doorway, including frame or stand. The Juror reserves the right to disqualify any work not suitably presented, or that varies from the submitted image.

## Entry Fees

The non-refundable entry fee is \$25 for up to three works (Arts Council Members pay \$20) and \$5.00 for each additional entry after that. There is no maximum number of entries, but no more than three works by any artist will be exhibited. Diptychs and triptychs will be considered as two or three entries. **Required: 1 image per each 2-D piece, 2 images per 3-D piece.**

## Entry Procedure

Entries will be accepted in the form of a JPEG image on a CD. High resolution images are preferred. We suggest 300 dpi at 4" x 6". Please label each image file with the artist's name and entry number (number 1, number 2, etc.). Also include title, medium, size (indicated as height first, length second). On the CD, please include artist's name, address, phone number and email. A stamped, self-addressed envelope must be provided with the CD. Declined entries will be returned with notification, accepted disks will be held for comparison by the juror.

**Please Include:** Entry Fee (payable to Arts Council), completed entry form, CD, and self-addressed and stamped return envelope.

## Shipment and Delivery

Shipping artwork to and from the exhibit is the responsibility of the artist. Artist may use his/her own shipping company preference, and is responsible for scheduling delivery and pick-up of artwork. Works must be labeled with artist's name, title of work, media, and price. **Shipping cartons must be reusable and within shipping guidelines.** Please use professional grade boxes. No packing peanuts allowed. Late or damaged work will not be exhibited. Hand deliveries will be accepted Tuesday – Saturday, 10-4.

## Return of Work

Exhibited, hand-delivered work **MUST** be picked up at the close of the exhibit, Saturday, January 26, **at the Arts Council**. If you are not able to pick up your pieces on this day, the Arts Council will hold your pieces until Jan. 30, 2013. Shipped works will be crated and ready for shipment by February, 8.

***It is the responsibility of the artist to provide postage and insurance to and from the exhibit and to schedule delivery and pick-up of the work.***

## Liability

Receipt of the completed form constitutes your agreement with all conditions established in the prospectus. It is the responsibility of the artist to provide all shipping costs and insurance on works during shipment. Consent to reproduce works photographically, for publicity purposes, is assumed to be granted.

All reasonable care will be taken with your works, but the Arts Council of Southeast Missouri will not be responsible for theft or damage incurred at the location. We recommend artists provide their own insurance coverage for each submission.
