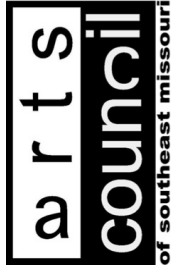

Jennifer Higerd grew up in a small town in Northwest Kansas. She received her BA cum laude in French, Political Science, and International Studies from Kansas State University and a Diplôme d'Études Françaises (Diploma of French Studies) from the Université de Rennes II in Rennes, France. She earned a BFA in Graphic Design and an MFA in Ceramics from Fort Hays State University.

She has travelled extensively in Western Europe, particularly in France, and taught in the Ivory Coast in West Africa. In the U.S., Jennifer has taught a variety of subjects to high school students, hearing impaired students, college students, and adult learners.

Her work has been exhibited in regional and national juried competitions. She is an Art Instructor and Gallery Coordinator at East Central College in Union, Missouri.

AWARDS

Cash awards will be given for Best of Show, Second Place, and three honorary awards. The Juror, whose decisions are final, will designate award recipients. Awards will be distributed at the exhibition opening reception Friday, December 7, 5 - 9pm, at the Arts Council of Southeast Missouri.

SALES + COMMISSIONS

Every effort is made to promote sales. The Arts Council of Southeast Missouri will retain a 30% commission.

STATEMENT OF PURPOSE

The Arts Council of Southeast Missouri's Regional Juried Art Exhibition was developed to provide a forum to demonstrate the diversity of this five-state region and the artists who live here. We encourage artists to submit works that interpret any aspect of the Southeast Missouri region as well as its bordering states. Work must interpret the people, places, or things that are representational of this region.

ELIGIBILITY

Open to all area artists 18 years and older living within the five state region (MO, IL, AR, TN, KY). Entries must be original, not previously exhibited at the Arts Council, or in any Arts Council sponsored Juried Exhibit. Maximum size **48" x 72" including frame**. Maximum weight: **75 lbs**. 2D Works must be framed, gallery wrapped canvas, or finished panel and wired for installation. **NO SAW TOOTH HANGERS**. Three-dimensional pieces must fit through doorway, including frame or stand. The Juror reserves the right to disqualify any work not suitably presented, or that varies from the submitted image.

ENTRY FEE

The non-refundable entry fee is \$35 for up to three works (Arts Council Members pay \$30) and \$5.00 for each additional entry after that. There is no maximum number of entries, but no more than three works by any artist will be exhibited. Diptychs and triptychs will be considered as two or three entries.

ENTRY PROCEDURE

Entries will be accepted in the form of a JPEG image on a CD, or through email. High resolution images are preferred. **Required: 1 image per each 2-D piece**. Also include title, medium, size (indicated as height first, width second) on the attached or online form, and please label digital images as: **smith01_title**.

For Mailed Entries, Please Include: Entry Fee (payable to Arts Council), completed entry form, CD, and self-addressed and stamped return envelope.

SHIPMENT & DELIVERY

Shipping artwork to and from the exhibit is the responsibility of the artist. **Artist may use his or her own shipping company preference, and is responsible for scheduling delivery and pick-up of artwork.** Works must be labeled with artist's name, title of work, media, and price. **Shipping cartons must be reusable and within shipping guidelines.** Please use professional grade boxes. **NO PACKING PEANUTS.** Late or damaged work will not be exhibited. Hand deliveries will be accepted prior to the deadline, Tuesday – Saturday, 10 – 6pm.

RETURN OF WORK

Exhibited, hand-delivered work **MUST** be picked up at the close of the exhibit, Saturday, January 26, at the Arts Council. If you are not able to pick up your pieces on this day, the Arts Council will hold your pieces until Feb. 5, 2019. Shipped works will be crated and ready for shipment by February 9. Any pieces not picked up or shipped by this date will be disposed of at the Arts Council's discretion.

It is the responsibility of the artist to provide postage and insurance to and from the exhibit and to schedule delivery and pick-up of the work. Please notify the Arts Council of scheduled pick-up dates.

LIABILITY

Receipt of the completed form constitutes your agreement with all conditions established in the prospectus. It is the responsibility of the artist to provide all shipping costs and insurance on works during shipment. Consent to reproduce works photographically, for publicity purposes, is assumed to be granted.

All reasonable care will be taken with your works, but the Arts Council of Southeast Missouri will not be responsible for theft or damage incurred at the location. We recommend artists provide their own insurance coverage for each submission.
